- Be a **full-time registered student** in one of the following: a high school in SD69 who is graduating in 2026, or a post-secondary program.
- Be **enrolled in studies that benefit wildlife**: Examples include the study of animal care, biology/ecology, coastal/marine studies, earth science/geology, environmental studies/education, natural resource protection, resource management, veterinary medicine OR other studies that directly benefit wildlife.
- Be a **Canadian citizen** who **currently lives or previously lived on Vancouver Island**.

## 2. Personal Statement

- ✓ Provide a short (400 – 500 word) personal statement describing your educational and career goals as you see them now.

### In your personal statement, be sure to address the following:

- Your interest in and commitment to wildlife management and/or environmental conservation
- Your career aspirations
- Describe how your course of studies relates to the objectives of wildlife management and/or environmental conservation. Please provide any additional information that should be considered when evaluating your application.

## 3. Resume

- ✓ Provide a current resume that details your education, work experience, honours and awards, relevant extracurricular events, and/or community activities, and employment.

## 4. Transcripts

- ✓ Provide copies of post-secondary transcripts from the institution in which you are currently enrolled.  
High School Students: Provide proof of acceptance into a post-secondary program.

## 5. References

- ✓ Provide two sealed letters of recommendation from references who can address your academic achievement and potential for success in post-secondary studies. References could include instructors, supervisors, or other professionals you've worked with related to your studies.

Download two (2) **Reference Request forms** and give them to 2 people who know you well (instructors, supervisors, related professionals, etc.) AND who are not members of your family. Ask them to complete and return the form and reference letter to you in a sealed envelope in time for you to meet the application deadline. **NOTE:** Only referees for short-listed candidates will be contacted.

## WHERE TO SEND YOUR APPLICATION

**Deadline: April 15, 2026**

Decisions on Successful Recipients will be made by May 1, 2026.

Successful Recipients will be notified directly by phone or email.
